### DEVICE USER AGREEMENT

This Student Computer Equipment Acceptance Form (the "Agreement") ensures that equipment supplied by the Deer Valley Unified School District (the "District") will be used and maintained in its original condition, reasonable wear and tear excepted, by the designated borrower named below ("Borrower"). By signing this form, Borrower will demonstrate reasonable care with the respect to the security and physical well-being of the equipment signed to his/her care. In the absence of reasonable care or if the equipment is returned in a condition different than the original condition, Borrower will be financially responsible. In addition, in the event the Deer Valley Unified School District determines in its sole discretion that the borrower did not utilize reasonable care in the use of the equipment, the borrower will be responsible for any damaged, lost, or stolen equipment. All specified equipment is and shall at all times remain the property of the District and must be returned by the last day of the school year or the student's last day of enrollment in the school, whichever comes first.

**To the extent Borrower is a minor, a parent must sign this agreement. By signing this agreement, both the Borrower and Parent acknowledge the receipt of the above equipment and agree:**

- To abide by the Deer Valley Unified School District Acceptable Use Policy and Tech Rich Digital Guidelines.
- To use the equipment primarily for educational use.
- That while the equipment is connected to the District network, Internet use will be filtered and logged.
- Web content filtering beyond the District network will be the responsibility of the borrower and parent.
- To not install or remove any software without prior authorization from the District.
- To report any problems or damages immediately to the advisor.
- That the equipment is the property of the District and must be returned prior to the borrower's last day of attendance of the current school year.
- To return the equipment before Borrower's last day of school if Borrower is transferring out of the District.
- That if the equipment is not returned to the District in its original condition, reasonable wear and tear excepted, or if the equipment is damaged, lost, or stolen, due to Borrower's negligence or not utilizing reasonable care in the use of the equipment, reasonable wear and tear excepted as determined exclusively by the District, Borrower agrees to be financially responsible for the replacement value of the equipment as determined by the District.
- That all information stored on equipment carries no expectation of privacy and is property of the District. Any information or use of the equipment carries no expectation of privacy. The District reserves the right, at all times and without prior notice, to inspect and search any and all its property for the purpose of determining whether any policy has been violated, or when an inspection and investigation is necessary for purposes of promoting safety or compliance with state and federal laws.

## OPTIONAL DEVICE PROTECTION PLAN

The Deer Valley Unified School District is providing a protection plan for students and parents as part of our Tech Rich 1:1 mobile device program. Enrollment in the plan is optional with the understanding that if students/parents do not enroll in the protection plan they may carry full liability for the mobile device (iPad or Chromebook) in the same way they do for other damaged or lost school property, such as textbooks.

Program Fees and Coverage
<ul style="list-style-type: none"> <li>• <b>Annual Premium:</b> <b>\$25</b> annually. <i>This fee is nonrefundable.</i></li> <li>• <b>Limit Liability:</b> \$430</li> <li>• <b>Coverage:</b> Repair or replacement of school issued iPad and case.</li> <li>• <b>Enrollment Deadline:</b> Must enroll in plan within 3 days of receipt of iPad device.</li> </ul>
Effective Coverage / Expiration Dates
<ul style="list-style-type: none"> <li>• <b>Effective Date:</b> Coverage begins when this form is signed and returned <b>and</b> the \$25 nonrefundable fee is paid.</li> <li>• <b>Expiration Date:</b> Coverage ends on the earliest of the following dates: last day of school year, return of device, no longer enrolled in school, or no longer qualified for the Tech Rich mobile device program. <i>Please be sure to return the device before the expiration date to ensure that coverage is always in effect.</i></li> </ul>
Coverage
<p><b>The Optional Device Protection Plan coverage includes:</b></p> <ul style="list-style-type: none"> <li>• Accidental damage caused by liquid, spills, drops, or other unintentional events.</li> <li>• Loss of device due to theft; claim must be accompanied by a valid police report.</li> <li>• Damage caused by fire; claim must be accompanied by official fire report from investigating authority.</li> <li>• Damage due to an electrical surge.</li> <li>• Loss or damage caused by natural disasters.</li> </ul>
Exclusions
<p><b>The Optional Device Protection Plan coverage excludes:</b></p> <ul style="list-style-type: none"> <li>• Damage caused by dishonest, fraudulent, intentional, and negligent (not locked and/or stored in an insecure manner or location) or criminal acts. Students and parents will be responsible for the full amount of repair/replacement for damage or loss that falls in this category.</li> <li>• Consumables: USB cables, AC adapters, case, or software.</li> <li>• “Jailbreaking” or otherwise voiding the manufacturer’s warranty by altering the software. <i>Jailbreaking</i> is a term used to describe a process by which normal manufacturer controls on the functionality of the device are bypassed. <i>Jailbreaking</i> of school-issued mobile devices is not permitted.</li> <li>• The Deer Valley Unified School District is not liable for any loss, damage (including incidental, consequential, or punitive damages), or expense caused directly or indirectly by the equipment.</li> </ul>
