

# CONGRATULATIONS GRADUATES!

State Farm Stadium is excited for the Class of 2021 to receive their high school diplomas! New policies and procedures have been implemented to keep everyone safe – but we need your help to make it a success.

## KNOW BEFORE YOU GO



### SHOWING UP 100%

Guests MUST NOT come to the stadium if they have COVID-19, COVID-19 symptoms, or know they've been exposed to COVID-19.

### FACE COVERING POLICY

In accordance with CDC recommendations, face coverings must be worn by everyone at all times while at State Farm Stadium. This applies to both inside of the stadium as well as the outdoor spaces around the stadium perimeter.

- In accordance with CDC guidelines, face shields are not an acceptable replacement for a face covering. Also, gaiters and face masks with exhalation valves or vents are not acceptable for use.
- Face coverings must be properly worn and must completely cover the nose and mouth unless actively eating or drinking in a designated seating area. The consumption of food or beverages on concourses or in other public spaces of the stadium is not permitted.
- This policy applies to all persons 2 years of age or older.

### TICKETING

A limited number of tickets will be distributed in order to facilitate physical distancing within the seating area at State Farm Stadium:

- Tickets are distributed by each individual high school; all questions should be directed to the high school
- Tickets will be distributed only in pods of two tickets
- Children 2 and under will not need a ticket if they are seated on the lap of a ticketed guest
- All guests must present a ticket upon arrival to the stadium
- Guests must sit in their assigned seat printed on their ticket
- If ADA accommodations are necessary, a Guest Services Representative will be on site to assist



### CAPACITY REDUCTION

Capacity reductions are in place to facilitate physical distancing. Congregating in groups or standing along railings is not permitted. Seating is grouped in pods of two.



### PHYSICAL DISTANCING

Physical distancing of at least 6 feet will be enforced at all times.

### PARKING

Graduate and guest parking is limited to the location designated by the graduate's high school. To encourage social distancing outside the facility, vehicles will be parked every other space. Please follow instructions from parking staff. Please put on your face covering prior to exiting your vehicle, so it is worn in the carpark and as you approach the stadium.



## INSIDE THE STADIUM



### CONTACTLESS ENTRY

Stadium entry will utilize every other door and physical distancing markers on the ground for line queuing.



### HEALTH SCREENING

For your safety, our employees will undergo temperature checks and health screening questions prior to entering the stadium.



### SANITIZATION MEASURES

State Farm Stadium has implemented ASM Global's VenueShield program that incorporates industry best practices designed to provide the highest levels of cleanliness and safety. Enhanced cleaning protocols throughout the stadium including all public spaces and surfaces, will take place prior, during and after every event.



### CONTACTLESS RESTROOMS

Motion-sensored sinks, soap dispensers, and toilets have been installed in all restrooms for your safety and convenience.



### HAND SANITIZING STATIONS

Touchless hand sanitizer stations are available for all fans throughout the stadium.



### CONCESSIONS

All food must be consumed in a designated seating area. Eating and drinking on the concourse or in other public spaces is not allowed. Purchase of concessions will be a cashless experience; cash will not be accepted.



### CASHLESS PAYMENTS

For guest and employee safety, cash will no longer be accepted at the stadium and ATMs have been removed from the premises. State Farm Stadium offers cash-to-card ATMs to convert cash to a universally accepted debit card.
