

# 2021 Summer Camp Agreement

**PLEASE READ BEFORE PROCEEDING!** By accepting this agreement and proceeding with the registration, you are agreeing with the terms and conditions of the DVUSD Summer Camp program as outlined in the Summer Camp Parent Handbook (link below or at [DVUSD.org](http://DVUSD.org))

**IMPORTANT!** *Your student is registered in this program when the following is complete:*

1. A current current copy of immunizations for each student being registered is submitted (a physicians copy is required as DHS does not accept the school/nurse's office copy). If current copy is not on file with Community Education, you will need to:
  - o Bring or mail a current copy to DVUSD Community Education, 7071 W. Hillcrest Boulevard, Glendale, AZ 85310 (school days from 8:00 a.m. to 4:30 p.m.)
  - o Fax a clear and readable copy to 623-376-3918 (please note child's school when faxing)
  - o Email a scanned, clear copy for the summer site your child will attend to:

    - or to [Community Education](#) (please include your child's summer location in the subject line)
  - o NOTE: Students entering kindergarten and 6th grade must have updated immunizations before the start of school
2. You receive a (second) email confirming that your registration has been approved by Community Education staff
3. Your payment has been successfully processed (per family registration fee PLUS \$100 PER CHILD deposit); this will be applied to your invoice for your first scheduled period
4. Signed your Emergency Information and Immunization Record prior to your child attending. Please allow extra time on the first day of attendance.

RATES and FEES for 'Sun'sational Summer Camp will be charged as follows:

- Per Family Registration Fee
  - o \$30\* through March 31st, provided all information and documentation received within 3 days of request
  - o \$60 Beginning April 1st
- Pick Your Days Plans (Per Child)
  - o 3-5 days per week; days and weeks may vary
    - \$40 per day Grades K-8
      - 1-3 days will charge at \$120 for the week
      - 4 days will charge at \$160 for the week
      - 5 days will charge at \$200 for the week
    - \$48 per day Preschool (as this age requires a smaller student to staff ratio)
      - 1-3 days will charge at \$144 for the week
      - 4 days will charge at \$192 for the week
      - 5 days will charge at \$240 for the week

**The per-family registration fee PLUS a \$100 deposit PER CHILD will be charged upon contract approval and be applied to your initial reservation dates; both fees are nonrefundable.**

**We will not participate in field trips this summer due to COVID19 restrictions. In the event of a quarantine, a 50% credit will be applied to future dates. No refunds will be provided.**

I agree to read the [Parent Handbook](#) and to follow all policies and procedures covered in this handbook. I understand there are conditions that may result in withdrawal of my child from a Community Education program, and that all DVUSD rules, policies, and procedures apply to this program. For the safety of all students and in compliance with DHS licensing, incomplete registrations can not be accepted. A 3-business day processing period is in effect following the approval of completed registrations before a student may attend the program. All locations are subject to minimum and maximum enrollment, and I understand that all days may not be available if I choose to enroll for less than the full summer.

By registering for this program, your email address will be used to send you periodic informational emails regarding this program.

\*Reduced registration fee will be forfeited if all required information and/or documentation is not received within 72 hours of request
