- I must participate in state-mandated testing (AzMERIT/Civics Test/AIMS) in accordance with ASRS 15808-B or I will be removed from the Deer Valley Online Learning Program. _____ (student initials)
- To ensure academic integrity of online learning, I must attend **in-person final exams** in accordance with ASRS 15-808-H. No early or late finals. _____ (student initials)
- If I am in a *Fast Track* course during the school year (not summer), I will complete **four hours a week of in-person attendance** at one of the online learning labs unless otherwise approved by my teacher or I will be withdrawn. (BGHS Tuesdays/Thursdays 3-7 PM or BCHS Tuesdays/Wednesdays 3-7 PM). I will also attend the required in-person orientation on the first day courses start. _____ (student initials)
- I will check my DVUSD learner email (username@learner.dvusd.org) regularly as this is how the Deer Valley Online Learning Program communicates. _____ (student initials)
- If I have technical or medical concerns that will prevent me from participating in my online course(s) for any period of time, it is my responsibility to contact my teacher(s) and the Deer Valley Online Learning staff immediately by emailing online@dvusd.org. _____ (student initials)
